Note To Participants:

Participation in the mediation process is mandatory, and each party must participate in person or by a representative unless leave is granted by the Court not to attend. Any application for leave to be excused **must be made in writing** to the Registrar, giving reasons and be served upon all other participants to the proceedings.

The Court has released a Practice Note on Alternative Dispute Resolution, which along with the attached trial mediation procedure for remote Court-assisted mediation dated 2 April 2020, will assist parties in the protocols around the mediation process. A copy of the Practice Note can be obtained through this Environment Court Registry.
