Mr P Thomas, Resource Management Consultant, Environmental Management Services Ltd.

Mr Thomas said he wished to talk to members at today's meeting as a representative and advisor to five joint appellants to the Council decisions not to grant new resource consents extending the previous three year consents for a maximum number of 35 overnight stays per annum in five specific boat sheds.

The boat sheds were at Cambourne.

Mr Thomas said that the Environment Committee had given specific instructions to officers that there was not to be any mediation or discussion with the appellants over the matter while it was before the Environmental Court.

Mr Thomas said that he would like to take today's opportunity to put directly before the committee some specific proposals for consideration in relation to addressing the reasons why the applications were refused.

A copy of Mr Thomas' oral submission was circulated.

Following questions, Councillor Buchanan thanked Mr Thomas for his representations and said officers would report to the next Environment Committee meeting on 13 September 2001 taking account of the comments made during today's meeting.

E 406 **Agent Orange Investigation**

Mr Strong, Section Leader, Resource Quality, summarised his Report 01.528 and said that so far his team had not been able to substantiate any of the claims being made about unwanted drums of toxic Agent Orange chemicals being dumped at different sites at the ICI New Zealand's manufacturing site at Seaview, Lower Hutt.

Results have not yet been released for the Wingate Landfall site. Research had found no record of dumping in Cook Strait or Pauatahanui Inlet.

Mr Strong said any chemicals discharged at the site would have seeped down into groundwater by now. Monitoring of groundwater wells at the site had shown no contamination.

Mr Strong said it was not clear whether Agent Orange itself was blended in New Zealand or overseas.

The Council would continue to investigate the issue.

Mr Strong concluded that the Regional Council has been trying to get information out of the public and the Council is concerned to ensure that any materials that may still be out there are located as soon as possible.
