Funding

The report was welcomed as a constructive and valuable blueprint for the future.

Councillor Evans noted that flooding in the Waiwhetu area was primarily a local rather than a regional issue and that any flood protection work to be undertaken as an outcome of the Waiwhetu study should be largely funded locally.

Councillor Baber asked that the study clearly identify local and regional benefits so that appropriate funding decisions can be made.

Waikanae River Floodplain Management: Haul Road on the South Bank

Councillor Turver noted that the Friends of the Waikanae River have raised concerns about the poor state of the Haul Road on the south bank. Councillor Turver further noted that people considered that the main use of the Haul Road was as a walking track and that it should be maintained accordingly. He said there was a need for a meeting with the local residents to explain the extraction works being carried out by the contractor in that area of the river.

Mr Forlong said a meeting will be arranged. Mr Forlong said he would try to arrange a visit and familiarisation tour of the Porirua and Kapiti area for Councillors before Christmas if possible.

River Management within the Waikanae River Mouth Scientific Reserve

Councillor Turver noted that a buildup of gravel in the lower part of the river could lead to flooding in homes further up the Waikanae Valley. He asked whether Mr Ross could facilitate the necessary gravel extrusions, next to and within the Scientific Reserve. Mr Ross said he would discuss with his staff the need for an agreement on the wider issues of river management and possible extraction within the Scientific Reserve as it affected the Waikanae River.

The Rimutaka Incline Walkway

Councillor Evans said that the Rotary Clubs in the Hutt Valley regarded the Rimutaka Hill Incline Walkway as an extension of the Hutt River Trail and trusted that improvements would continue on the incline Walkway. Councillor Laidlaw suggested that a representative from the Rotary Clubs be invited to brief the Committee at a subsequent meeting.
