##### **Mr Chris Horne, 28 Kaihuia Street, Northland**

Mr Horne spoke to Item 3 concerning the vision, objectives and policies of the Regional Land Transport Strategy. Mr Horne listed a number of principles that should govern the Strategy including the ratification by New Zealand of the Kyoto Protocol. Mr Horne said that the only ways to move people environmentally, socially and economically were by public transport, walking and cycling and requested that the members of the Committee develop a fully sustainable transport system.

A copy of Mr Horne's representations were circulated.

The above **amendment** was **passed** on a vote by a show of hands 11 votes in favour and 5 votes opposed.

Mayor Prendergast requested the following changes in Report 04.626:

- (1) 4.2 on Page 2 of Report 04.626 Paragraph 4.2 **Objective to Assist Safety and Personal Security**, be amended so that the paragraph reads as follows:
 

“Achieving a safer community through our land transport system that improves or achieves regional road casualty targets and contributes to a sense of individual and community security when using the transport system”.
- (2) The bullet points listed under 5.1 **Network and Service Improvement and Responsiveness** have an additional sentence at the beginning of the section noting that the bullet points are not listed in any special order of priority.

- (3) Under 5.3 **Securing Transport Funds** the second bullet point under Paragraph 5.3 be amended to read as follows:

“Advocate for any necessary rail investment”.

With leave of the **meeting** and the agreement of the **mover and seconder** it was noted that the above points will be included in the amended motion.

Mayor Ogden requested that under 5.3 **Securing Transport Funds** the first bullet point be amended to read as follows:

“Advocate for increased transport funding and effective advocacy”.

With leave of the **meeting** and the agreement of the **mover and seconder** the above will be included in the amended motion.

Mr Anderson asked a question about support for trolley buses in Wellington City and their continual upgrade. Councillor McDavitt said the request was best answered by a briefing from officers.

**Page 2 State Highway 1 Plimmerton to Paremata Upgrade**

Responding to a question from Mayor Brash, Mr Hasell said there would be no work undertaken at the Paremata Roundabout for two weeks over the Christmas period. The site will be as safe and clear as possible and speed will be restricted. Work will recommence about 10 January 2005. Transit New Zealand will issue a press statement.

**Waikanae Electrification Package**

Responding to a question from Councillor Turver Dr Watson gave a summary of recent structural changes in the Railway and Government sector and said firm details concerning the Waikanae Electrification Package would not be available until the Western Corridor Review had been completed.

**Hutt City Council**

Councillor Evans requested future reporting combine the Valley Floor Connector and the Petone Grenada Link. They are not separate projects.

**Hutt City Council – Road Toll Casualty Statistics**

Mayor Brash requested that future reports include specific details for State Highways 1 and 2.

**Road Safety**

Mrs Kennedy said that the Minister of Transport had recently signed three new land transport rules:

- (1) Traffic control devices 2004.
- (2) Land Transport (Road user) Rule 2004.
- (3) Vehicle Lighting 2004.

**Cycle Facilities**

Mayor Ogden said that broken glass from crashes on the Hutt Motorway should not be swept onto the cycle lane connecting Wellington and Petone.
