RLT 49 **Western Corridor Plan Hearing Subcommittee**

Councillor McDavitt vacated the Chair and Councillor Wilde presided for the following item. He took no part in the discussions and did not vote on any of the matters pertaining to this item.

Councillor Wilde advised that:

- she and Mayor Brash had amendments to the above motion
- rather than many motions and amendments on the issues, the recommendations in the report be moved and seconded to enable discussion and consensus

- Mayor Brash's amendments be tabled for discussion, and
- individual elements be dealt with.

**Noted**

- (1) That Mr Taylor participated on the Western Corridor Plan Hearing Subcommittee only to approve the documentation released for public consultation.
- (2) That Transit New Zealand had appointed Mr Alan Bickers to replace Mr Taylor as its representative on the Subcommittee.
- (3) That Transit New Zealand does not have an obligation to consult with each of the relevant mayors of the local territorial authorities on the consenting strategy, but is doing so.
- (4) That Mayor Brash had withdrawn her suggested amendment 3.

**Agreed** with respect to Mayor Brash's amendments and the Terms of Reference attached to Report 05.552 that the:

- (1) Naming issue be decided later in the meeting.
- (2) Powers section of the Terms of Reference of the Western Corridor Plan Hearing Subcommittee be modified (identified in italics) as follows:

**Bullet Point 5 to now read**

“Seek clarification from the Study Team *or any other appropriate people* on technical matters.”

**Bullet Point 8 to now read**

“Receive *information from* the Transit New Zealand Board in relation to the state highway components of the Corridor Plan.

**Bullet Point 9 to now read**

“*Conduct a preliminary review of* all cultural, economic, environmental, social, costing and technical information and the results of the consenting strategy for the coastal route.

**Bullet Point 10 to now read:**

“Prepare a report *of its findings for* the Regional Land Transport Committee and Transit New Zealand with conclusions regarding a Western Corridor Plan.

- (3) Responsibilities section of the Terms of Reference of the Western Corridor Plan Hearing Subcommittee be modified as follows:

**Bullet point 4 to now read**

“The process is robust and transparent and the summary of the consultation process adequately, fairly and demonstrably reflects the submitters’ comments.”

Councillor Wilde advised that:

- most of the issues raised by the amendments suggested by Mayor Brash and herself had been dealt with other than the subcommittee name
- the two earlier motions dealing with amendments would be considered as part of the substantive motions
- she would put each of the original recommendations to the vote.
