Mayor Wayne Guppy welcomed Councillor Chris Laidlaw, Chairman, Landcare Committee, Councillors and staff to the Upper Hutt City Council. Chris Horne and Barbara Mitcalfe

Chris Horne and Barbara Mitcalfe spoke in support of their written submission on the Kaitoke Regional Management Plan Review. They requested the Committee to consider the establishment of tramping access from Pakuratahi Forks to Frances Stream and Akatarawa road and/or an alternative potential route to Akatarawa Road as outlined on a plan circulated by Mr Horne.

Barbara Mitcalfe, Wellington Botanical Society

Barbara Mitcalfe spoke of the need to continue restoring the Te Marua bush remnant. In particular, she referred to Page 30 of the Greater Wellington publication *Managing Your Bush Block* a guide to looking after indigenous forest remnants in the Wellington region. Page 30 describes the Greater Wellington's community partnership protecting Te Marua Bush. Barbara Mitcalfe said the Botanical Society valued the partnership and trusted the existing joint management relationship will continue.

- (c) That the bringing forward of \$82,000 expenditure from 2005/06 (loan funded) be approved for extending the new capital edge protection works on the lower Otaki River.
