**Rosamund Atherton** requested that more timetables be added to bus stops – particularly in the Wellington Bays and Miramar Peninsula area. She also suggested that some regular routes be extended.

**Paula Warren** maintained that the general public will be encouraged to use public transport when the service and facilities offered are of high quality. She also complimented Greater Wellington on its encouragement of public transport advocacy groups.

**Jeremy Ward** requested that Greater Wellington not proceed yet with a decision on whether or not a Days Bay – Seatoun – Queen’s Wharf sailing would be approved.

**Brent Efford** congratulated Greater Wellington on recent developments in passenger transport, but pointed that that level boarding is not yet available on the new Wairarapa trains. He tabled a page of photographs showing how this system operates at two stations in the United Kingdom.

**John Vanisselroy**, on behalf of the Rail and Maritime Transport Union, reported that bottlenecks are still a problem on railway routes. The extension of double tracking to Waikanae is laudable, but is not the complete answer. Mr Vanisselroy expressed, on behalf of his union, a desire to be consulted more over rail public transport matters.
