


## Lake Wairarapa and surrounds

WAR140282	F & M DONALD LIMITED	23	Moonmoot pump drain	<p>Due to the fluctuating nature of levels in Lake Wairarapa, restrictions are applied at the direction of Greater Wellington Regional Council. Direction to cease abstraction will be given when:</p> <ol style="list-style-type: none"> <li>1. The water level in Lake Wairarapa is at or below the minimum target lake levels*, and</li> <li>2. The levels in the lake have been receding for the preceding five days, and</li> <li>3. The flow in the Tauherenikau River at Gorge falls below 1300 litres/second.</li> </ol> <p>Only once all three trigger levels occur simultaneously must abstraction cease.
