MAY IT PLEASE THE COURT

1. This notice is filed on behalf of Porirua City Council (**PCC**) in relation to its appeal on the decisions of the Wellington Regional Council on the Proposed Natural Resources Plan for the Wellington Region (**Proposed Plan**).
2. Following further engagement with the Wellington Regional Council, PCC seeks to withdraw its appeal points in relation to the following provisions in the Proposed Plan:
 - (a) Definition of “noise sensitive activities” (appeal point 8 in Appendix A of PCC’s Notice of Appeal);
 - (b) Definition of “vegetation clearance” (appeal point 13 in Appendix A of PCC’s Notice of Appeal);
 - (c) Policy P73 (appeal point 28 in Appendix A of PCC’s Notice of Appeal);
 - (d) Rule R100 (appeal point 39 in Appendix A of PCC’s Notice of Appeal);
 - (e) New rule to sit after Rule R116 (appeal point 47 in Appendix A of PCC’s Notice of Appeal); and
 - (f) Map 35 (appeal point 59 in Appendix A of PCC’s Notice of Appeal).
3. For clarity, PCC confirms that:
 - (a) It wishes to remain a section 274 party to the Masterton District Council and South Wairarapa District Council appeals on Rule R100 and does not withdraw its interest in those appeals; and
 - (b) It wishes to remain a section 274 party to the Wellington Water Limited appeals on Policy P73 and Rule R116 and does not withdraw its interest in those appeals.
4. PCC does not consider there to be any issues as to costs.

5. An amended Notice of Appeal is attached to this notice as **Appendix A**.
